GENERAL TERMS & CONDITIONS

- 1. (a) NHDC conducts the Expos on behalf of office of DC (Handlooms), Ministry of Textiles. Only the Parties capable of providing Infrastructure material of Octonum System and having good experience of executing similar type of work for Govt Organization, Trade Fair etc are eligible to apply. The quotation shall be submitted for all items as per schedule in a Sealed Envelop.
 - (b) Tenders received after the stipulated date and time on account of any reason such as postal delay etc. shall not be considered.
- 2. Tenderer should quote the rate for the each specified item mentioned in the documents and, rates, if quoted in vague manner, or in any other type/form which differ from the specified item, are not liable to be considered. Rates guoted should be clear in meaning and reference.
- 3. Duration of the Exhibition at each place is only for 14 days, however in case of extension of the same for less than three days no extra payment shall be made and in case it is extended for more than three days, the payment for extended days shall be made at the rate not exceeding proportionate cost for 14 days. The space for commencement of the work relating to the erection of stall and other Electrical Work shall be made available 2 days in advance and shall have to be completed by the contractor at least 12 Hrs. before the inauguration date. The progress of work shall be supervised and checked by the authorized representatives of the NHDC Limited. Tenderers MUST inspect the site for physical condition before planning/execution of work order. Tenderer should quote Item-wise rate for each event / place separately. Event-wise rates quoted by the agencies will be considered for that particular event.
- 4. In case any portion of infrastructure work is not completed as per laid down standard and handed over to the authority, penalty upto 5% of the total value of the work allotted/awarded shall be imposed for each day of delay by the authority.
- 5. The volume of the work may vary according to the actual requirement at site which shall be at the discretion of the Corporation, and final payment to the contractor shall be regulated on the basis of actual work executed at the rates initially approved.
- 6. The Contractor shall be responsible for upkeep & daily cleaning of exhibition Hall inside (atleast two times a day by vacuum cleaner during the entire exhibition period) and maintenance of the entire work done by him, till the closing of the exhibition for which no extra payment shall be made. Breakage/damage in any infrastructure work shall immediately be rectified and no extra payment shall be made for the same.
- 7. Contractor is not allowed to sublet whole or part of the contract without the prior written permission from the Corporation .
- 8. With regard to electrical fitting etc. the contractor shall have to engage a qualified licensed electrical contractor entitled to erect, handle and maintain high tension supply line and its maintenance and upkeeps.
- 9. No Advance/part payment shall be made to the contractor. Final payment will be made only after the completion of the exhibitions on submission of bills/documents etc. duly certified by the NHDC incharge of the exhibition.

- 10. The tenderer should fill the rate tendered in figures as well as in words. The tender form may be filled in English/ Hindi and all entries should be made by hand and written with Pen. Over writing in rates is not permitted. All corrections should be attested by the tenderer with his initials as many times as the corrections occur. Each page of the tender form and other related papers submitted therewith be signed by the tenderer.
- 11. Tenderers are required to deposit an Earnest Money of Rs.50,000/-(Rupees Fifty Thousand Only). The payment of earnest money will be accepted only in the form of FDR/DEMAND DRAFT drawn in favour of the National Handloom Development Corporation Ltd. payable at Lucknow from scheduled Bank. The tender without earnest money will not be accepted.
- 12. The earnest money of successful tenderer will be retained as security for successful completion of the contracts and shall be returned without any interest after exhibitions are over.
- 13. It is proposed to organise Special Handloom Expo "Silk Fab"/"Wool Fab" at 20 places. The corporation has a right to cancel one or more or all events at any moment without assigning any reason what so ever or change the date of the events/contractor for any event. No compensation at all against such losses if any, will be given to the Contractor for the events concerned.
- 14. The successful tenderer shall immediately and not later than next three days of intimation of acceptance of tender, sign and return a copy of order as acceptance of the order, terms & conditions of the Corporation. Failure to do so shall give the Corporation the right to revoke the acceptance of the tender without further notice to the tenderer, forfeit the earnest money deposit and award the work to any other contractor.
- 15. The Corporation reserve the right not to accept the lowest tender, the right to reject may or all tenders and award the remaining work to any other contractor without assigning any reason. Conditional tenders in any form, whatsoever shall be liable to be rejected outrightly.
- 16. The Corporation shall be entitle to cancel the contract, if it is found that there has been any breach of condition of the contract and / or the work is found to be unsatisfactory. The Contractor in such cases will not be entitle for making any claim / compensation. The Corporation is entitle to forfeit the earnest money and the contractor may not be considered for award of any similar contract in future.
- 17. The contractor is responsible for observing all the relevant labour laws in force during the execution of the contract. For works outside the work order, contractor will have to quote rates separately. For all such works the Corporation reserves the right to pay the lowest of the rates quoted by the competing contractors or on the basis of assessment of reasonable market rates.
- 18. In some cities, the selected hall / venue may have the terms / conditions, that only the agencies empanelled with them are allowed for Infrastructure Work in their Hall. In such circumstances, NHDC Ltd will be at liberty to award work order to such agency and NHDC's Contractor shall not be entitled for any compensation etc.
- 19. In case of any dispute or differences, breach & violation relating to the terms of the contract, the said matter or dispute, differences shall be referred to MD, NHDC for arbitration, who himself or any other person appointed by him will work as sole arbitrator and the award of the arbitrator shall be final and binding on both the parties.
- 20. The rates of all items of work shall include cost of all labour, transportation, octroi and all type of taxes etc. (Sales tax / VAT/ Service Tax etc.)

21. While submitting the tender, the tenderer should submit the following:-

- a) Authentic proof of the work done of similar nature and value with any Government Authority or National Handloom Expo . Enclose Certificate etc.
- b) The turnover of the Agency during last three tinancial year shall not be less than Rs: 2 Crores. A certificate of Chartered Accountant shall be submitted to that effect.
- c) Income Tax Clearance Certificate. A copy of TAN/PAN no.certificate is also required to be enclosed with the tender documents.
- d) Service tax registration certificate (Proof to be submitted alongwith copy of latest service tax return filed)
- e) Proof of Financial status and credit worthiness of the firm from scheduled bank be enclosed.
- f) Earnest Money Deposit (EMD) -Rs.50,000/ only.




